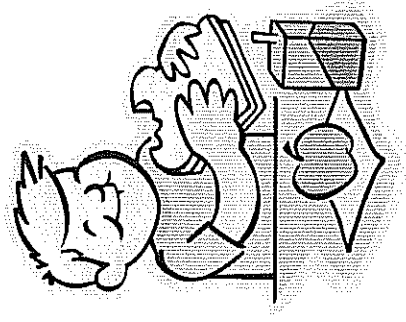

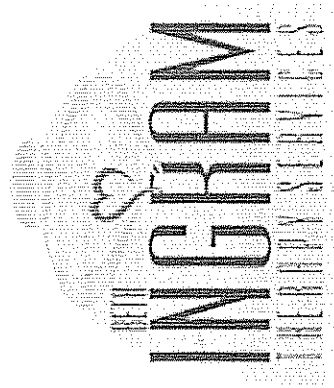

## *"Swallow Right"*

**WHAT:** A Tongue Thrust Correction Program utilizing Roberta Pierce's *Swallow Right: A Program for Correcting Swallowing Patterns*

**WHO:** Children (at least 8 years of age) with a tongue thrust swallowing pattern that is interfering with dental growth and development (e.g., overjet, open bite) and/ or speech production (e.g., lisp)

**WHEN:** Program length is 12 to 14 weeks for approximately 12 therapy sessions. Therapy sessions are once per week for 30 minute sessions. Initial evaluation conducted prior to therapy sessions.
